#### Public Safety Technology Update and Camera Deployment

Even though burglary and theft rates has decreased by 65% from 2016, the Hillsborough Police Department continues to study uses of new technology to complement existing crime prevention strategies. In addition to using Automated License Plate Recognition equipment, which has read over 157,500 license plates, the Police Department will soon be using high definition camera equipment systems.

The City Council authorized the department to proceed with the testing and evaluation of two camera systems, which will be deployed in high volume traffic locations in the coming weeks. The cameras are intended to prevent and deter criminal activity, and assist in identifying, prosecuting and convicting those responsible for crimes. This technology can also monitor

vehicle and pedestrian traffic, aid in collision investigations, and assist the department in responding to critical incidents. This technology is intended to complement the Police Department's ongoing partnership with residents to report crimes or suspicious activity. Staff will report back to the City Council with study results at a future City Council Meeting.

#### Wireless Communication Facilities Legislation and Pending Project Update

On June 12, 2017, the Hillsborough City Council received a presentation from Dr. Jonathan Kramer of Telecom Law Firm PC regarding new Senate Bill 649 which, if enacted, would reduce local government control and revenue opportunities for wireless communication facilities. This potentially means that wireless towers and associated equipment/cabinetry may be placed within the Town with little to no public review. The bill was introduced by Senator Hueso (San Diego) and Assembly Member Quirk (Alameda) and passed with a 32-1 vote by the State Senate on May 31, 2017. The bill is projected to be heard next by the California State Assembly within the next month. The Town will continue to advocate for local control over wireless communication facilities.
