**Notice of Application**  
**Proposed Wireless Communications Facility**

The Town of Hillsborough has received an application for a proposed wireless communications facility (WCF) identified as: **H20m3, located adjacent to 1180 Marlborough Rd.**

You are receiving this notice pursuant to Hillsborough Municipal Code (HMC) Section 15.32.060.B as the location of this proposed wireless communications facility is within 500 feet of the real property that you own or occupy according to available records.

**APPLICANT:** Crown Castle

**DESCRIPTION:** This proposed new steel pole site is within the public right-of-way located behind the traffic barrier and supported by a steel platform. This site will have an Amphenol canister antenna installed in a 7'6" radome at the top of the new integrated steel monopole. The integrated steel pole base will accommodate a 4449 radio (700 MHz) and a 4455 radio (1900MHZ/2100MHG) as well as two power supply units. The proposed node equipment is 100% passively cooled and will emit no mechanically generated noise. A small separate meter pedestal and flush to ground pull box will be installed near the new pole. The proposed height of the new facility is 35 feet.

**PROPERTY OWNER:** Town of Hillsborough (Public right-of-way)

**APPLICATION MATERIALS:** Application materials are available for public review online at: <https://www.hillsborough.net/wirelessapplications>. Printed copies of the application will be available for in-person viewing in front of Town Hall every Tuesday afternoon from 2:00-4:00 p.m. through April 20, 2021 to allow us to observe COVID-19 public protocols. Crown Castle has posted a sign board at the proposed site as required by HMC Section 15.32.060.E.

**PROCESSING TIMELINE:** This application is one of a total of thirteen (13) applications for proposed WCFs that the Town received from Crown Castle on March 23, 2021. The applications were submitted and must be processed according to the timeline in the approved settlement agreement that the Town entered into on June 8, 2020 that related to Crown Castle's lawsuit contesting the Town's 2018 denial of 16 WCF applications. Pursuant to HMC Section 15.32.080.E, the City Manager has referred all of these applications to the City Council for decision.

The City Council will hold public hearings to consider each application and render a decision. An initial City Council hearing to set the application review procedures and the City Council schedule for the public hearings for the 13 applications is tentatively scheduled for Thursday, April 15, 2021 at 6:00 p.m. via the City Council Zoom meeting platform. This meeting will be duly noticed
