**Notice of Application**  
**Proposed Wireless Communications Facility**

The Town of Hillsborough has received an application for a proposed wireless communications facility (WCF) identified as: **H02m3, located across from 400 El Arroyo Road.**

You are receiving this notice pursuant to Hillsborough Municipal Code (HMC) Section 15.32.060.B as the location of this proposed wireless communications facility is within 500 feet of the real property that you own or occupy according to available records.

**APPLICANT:** Crown Castle

**DESCRIPTION:** The project involves installing a new wood pole within a water tank property. This site will have an Amphenol canister antenna installed in a 8'0" radome at the top of the new wood pole. One 4449- radio (700 MHz) and a 4455 radio (1900MHZ/2100MHG) will be installed in a shroud attached to the pole as well as two power supply units and a fiber termination unit. The proposed node equipment is 100% passively cooled and will emit no mechanically generated noise. The proposed height of the new facility is 55 feet.

**PROPERTY OWNER:** Town of Hillsborough (Town Owned Property)

**APPLICATION MATERIALS:** Application materials are available for public review online at: <https://www.hillsborough.net/wirelessapplications>. Printed copies of the application will be available for in-person viewing in front of Town Hall every Tuesday afternoon from 2:00-4:00 p.m. through April 20, 2021 to allow us to observe COVID-19 public protocols. Crown Castle has posted a sign board at the proposed site as required by HMC Section 15.32.060.E.

**PROCESSING TIMELINE:** This application is one of a total of thirteen (13) applications for proposed WCFs that the Town received from Crown Castle on March 23, 2021. The applications were submitted and must be processed according to the timeline in the approved settlement agreement that the Town entered into on June 8, 2020 that related to Crown Castle's lawsuit contesting the Town's 2018 denial of 16 WCF applications. Pursuant to HMC Section 15.32.080.E, the City Manager has referred all of these applications to the City Council for decision.

The City Council will hold public hearings to consider each application and render a decision. An initial City Council hearing to set the application review procedures and the City Council schedule for the public hearings for the 13 applications is tentatively scheduled for Thursday, April 15, 2021 at 6:00 p.m. via the City Council Zoom meeting platform. This meeting will be duly noticed 15-days in advance of the meeting date, once confirmed.
